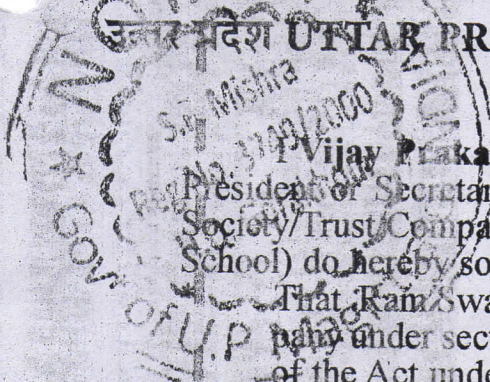

further utilized for promoting the school.

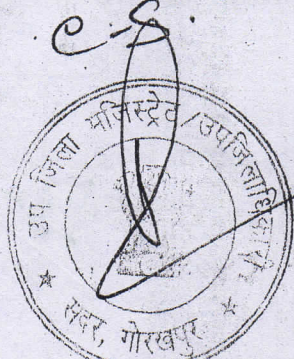
